



### **SPARROW 2003 LIMITED WARRANTY**

CorbinMotors.com will provide for repairs to the vehicle in accordance with the following terms, conditions and limitations.

**Warranty Applies.** This warranty is for the CorbinMotors.com SPARROW and is provided to the original and any subsequent owner of the vehicle during the warranty period, provided that the vehicle is serviced at an authorized SPARROW facility.

**Warranty Service is Available Only in a Limited Geographic Area.** The SPARROW incorporates a variety of design innovations, making it very different from vehicles using internal combustion engines. It takes special training and expertise to provide service on this vehicle. Only technicians with electrical training and expertise and properly trained electrical technicians (people in the electric service vehicle trade who service forklifts, boats, scissor lifts, etc.) should perform warranty work or service work of any kind on this vehicle. Your SPARROW Dealer will give you up-to-date information about the location of facilities where warranty service is available. #### **WHAT IS COVERED**

**I. Repairs Covered.** This warranty covers repairs to correct any vehicle defect related to materials or workmanship occurring during the WARRANTY PERIOD. Needed repairs will be performed using new or remanufactured parts.

**II. Warranty Period.** The WARRANTY PERIOD for all coverage begins on the date the vehicle is first delivered or put in use by the dealer and ends at the expiration of the COVERAGE period.

**III. Bumper to Bumper Coverage.** The complete vehicle is covered for 2 years or 18,000 miles, whichever comes first, except for other coverage listed here under "What is Covered" and those items listed under "What is Not Covered". For warranty on the AC controller and AC motor see the attached Addendum A for terms and conditions of the original equipment manufacturer's limited warranty.

**IV. Obtaining Repairs.** To obtain warranty repairs, return your Vehicle to a SPARROW Dealership authorized to service your SPARROW within the WARRANTY PERIOD and request the needed repairs. A reasonable time must be allowed to perform necessary repairs.

**V. No Charge.** Warranty repairs, including parts and labor, will be made at NO CHARGE.

#### **WHAT IS NOT COVERED**

**I. Tire Coverage.** Tires are not covered by this warranty.

**II. Battery Coverage.** Batteries are not covered by this warranty, but are separately warranted by the battery manufacturer for 90 days. However, CorbinMotors.com will replace the batteries during this period if they fail due to defect or workmanship. The battery manufacturer guarantees to the original personal user of the deep cycle batteries they will be free from defects in material or workmanship for 90 days after date of purchase. User will promptly report any alleged defects to authorized Sparrow Dealers, and permit examination by their service personnel. If the authorized Sparrow Dealer finds the battery to be defective as a result of material or workmanship, they will provide a replacement F.O.B. their location.

**III. Damage Due to Accidents, Misuse, or Alteration.** Damage caused as the result of any of the following, is not covered: a) Collision, fire, theft, storing with batteries in a discharged state, discharging battery pack below 135 volts, vandalism, riot, explosion or objects striking the vehicle; b) Misuse of the vehicle such as driving over curbs, improper towing, overloading, racing or other competition. c) Alteration or modification to the vehicle including the body, chassis or components, after final assembly by CorbinMotors.com. In addition, coverage does not apply if the odometer has been disconnected or its reading altered, or the mileage cannot be determined. d) Service performed by anyone other than a certified SPARROW technician could damage the vehicle. Such damage is not covered by warranty. e) This warranty provides no coverage on vehicles currently or previously titled as salvaged, scrapped, junked, or totaled.

**IV. Damage Due to Environment, Chemical Treatments or Aftermarket Products.** Damage caused by airborne fallout (chemicals, tree sap, etc.) stones, hail, earthquake, water or flood, windstorm, lightning, the application of chemicals or sealants subsequent to manufacture, etc., is not covered.

**V. Damage Due to Insufficient or Improper Maintenance.** Damage caused by failure to follow the recommendations of the maintenance schedule intervals or by failure to use or maintain fluids is not covered. All vehicles require maintenance. Items requiring replacement or repair (brakes, wiper blade etc.) as a result of vehicle use or exposure are not covered.

**VI. Extra Expenses.** Economic loss or extra expense is not covered. Examples include: Loss of vehicle use, Inconvenience, Storage, Payment for loss of time or pay, Lodging and meals or other travel costs.

**Other Terms.** This warranty gives you specific legal rights and you may also have other rights which vary from state to state.

**I. CorbinMotors.com does not authorize any person to create for it any other obligation or liability in connection with the SPARROW. Any implied warranty of merchantability or fitness for a particular purpose applicable to this vehicle is limited in duration to the duration of this written warranty. Performance of repairs, needed adjustments and CorbinMotors.com recommended maintenance are the exclusive remedies under this written warranty or any implied warranty.**

**II. CorbinMotors.com shall not be liable for incidental or consequential damages (such as, but not limited to, lost wages) resulting from breach of this written warranty or any implied warranty.** Some states do not allow limitations on how long an implied warranty will last or the exclusion or limitation of incidental or consequential damages, so the above limitations or exclusions may not apply to you.

**Warranty Repairs - Component Exchanges.** In the interest of customer satisfaction, CorbinMotors.com may offer exchange service for warranty repairs on some vehicle components. This service is intended to reduce the amount of time your vehicle is not available for use due to repairs. Components used in exchange are service replacement parts which may be new, remanufactured, reconditioned or repaired, depending on the component involved. All exchange components used meet CorbinMotors.com standards and are warranted the same as new components. Examples of the types of components that might be serviced in this fashion include: radios, CD players, individual batteries, and battery packs.

**Paint and Appearance Items.** Defects in paint, upholstery or other appearance items are normally corrected during new vehicle inspection or during pre-delivery inspection. If you find any paint or appearance concerns, advise your Sparrow Dealer as soon as possible. Deterioration due to use and exposure is not covered by the warranty.

**Mileage Extensions.** Prior to delivery, some mileage is put on your vehicle during testing at the assembly plant, during shipping and while at the retail facility. The retail facility records this mileage on the Vehicle and Owner Identification Card at delivery. For eligible vehicles, this mileage will be added to the mileage limits of the warranty, ensuring that you receive full benefit of the coverage. Mileage extensions: a) Apply only to new vehicles held exclusively in new vehicle inventory. b) Do not apply to used vehicles, CorbinMotors.com owned vehicles, Dealer-owned vehicles, or Dealer demonstrator vehicles.
